

FLEXIAUCTION EAR TAG SCANNING

PURPOSE

Scanning of ear-tags for the purpose of importing it into Flexiauction in the correct format to process it for the sales record, ownership of animals, and printing of documentation, as well as traceability purposes.

TERMS USED

BSNR

Unique alphanumeric code linked to each customer (buyers and sellers) in FlexiAuction for the auction.






In Flexiauction click



to register a BSNR or "mark" or "bidder number" for each buyer and seller participating at the auction



ALL PARTICIPATING BUYERS AND SELLERS MUST HAVE A UNIQUE BSNR.

THE BSNR CAN ONLY BE USED <u>EITHER</u> ON BUYER SIDE OR ON SELLER SIDE, IT SHOULD <u>NEVER</u> BE USED ON <u>BOTH</u> BUYER AND SELLER SIDE.

E.G. SELLER PETER HAVE BSNR "P1" AS SELLER BSNR FOR ANIMALS SOLD.

IF HE ALSO MAKE PURCHASED, THOSE LOTS SHOULD HAVE A **DIFFERENT** BUYER BSNR, E.g. "**BP**"

A BSNR PREFIXED WITH "NS" SHALL HAVE THE MEANING THAT IT IS AN UNSOLD ANIMAL AND SHOULD RETURN BACK TO THE SELLER

E.G. SELLER PETER HAVE BSNR "P1" AS SELLER BSNR FOR ANIMALS SOLD. ALL HIS UNSOLD ANIMALS MUST BE MARKED WITH "NSP1" ("NOT SOLD" - P)

THE BSNR CODE IS <u>ESSENTIAL</u> IN IDENTIFYING TAGS. <u>ALL</u> TAGS MUST BE LINKED TO A BSNR

SCANNING


EVERY animal should be scanned TWICE. This is to allow for both arrival and departure records. For arrival records this can be done at arrival when unloading inbound, or prior to entering the ring. For departure records this can be done when exiting the ring, or at departure loading outbound.



It is important that <u>EVERY</u> tag is linked to an associated BSNR when scanned, otherwise, the system will not be able to link that tag correctly. This alphanumeric code is NOT linked to a database when scanned, the auction office will link it to the correct customer in Flexiauction (*from pre-registration, loading certificates, vendueroll, kraal number, paint mark, etc)* The auction office will determine the correct BUYER and correct SELLER from this BSNR linked to it for the transaction.

You will be able to scan the ear-tags with a RFID scanner.

Flexiauction will allow for two methods to IMPORT the scanned tag data: EXCEL or FMTAG



Scanner Setup Note: It is <u>required</u> to have a field on the scanned for the <u>BSNR</u>.

On the scanner this field should be an alphanumeric **TEXT** field named "**BSNR**" and must be **compulsory/required**. It should be **repeated**, in other words allowing operator to capture/enter/type a BSNR for all the tags scanned subsequently for that specific BSNR.

In an ideal environment where capturing was faster and time constraints less, it would be ideal to also have these FlexiAuction supported optional fields: Location (arrival/departure), Reference Nr, Group Nr, Kraal Nr, Mass, buyer mark, seller mark, Sex and captured Lot Nr.

All Information is kept in the scanner memory until at such time the sessions are downloaded to a device (computer/laptop/mobile). The actual importing interface from the scanner will be dependent on the functionality provided by the software (provided by the manufacturer of the scanner). *E.g. CSV, Excel.*

This csv/excel file will be available for import into FLEXIAUCTION. (explained below in the FlexiAuction IMPORT EXCEL section)



The scanner is connected to a mobile device, and the mobile device will capture the tags from the scanner. We do provide a PWA web application for this purpose.



Please connect your scanner to a mobile device via Bluetooth or USB. Please ensure that you are using the <u>HID</u> or <u>KEYBOARD WEDGE</u> mode, as this is **simulating** the KEYBOARD in capturing the tags.


Note: this will simulate a keyboard, you can use <u>ANY</u> software to collect the tag info. E.g. Excel, Word, etc.



click "SET" to set the BSNR, GROUP and ARRIVAL/DEPARTURE for the batch you are about to scan.

Capture the BSNR, the code linked to the buyer/seller. Entry of this field is required



Capture the **GROUP** - This is an **optional** code that can be assigned to each tag to allow for identifying a "group of animals", e.g. all the animals in the same kraal or the same lot. Will be filled automatically.




LOCATION - ARRIVAL or DEPARTURE

Click **ARRIVE** or **DEPART** or to set mode for

arrival/inbound/offloading tags or departure/outbound/loading tags.

Keep the cursor in the TAG entry field, and ensure that each tag is captured.



Counters and logging info will be displayed below with a beep.



Here you will see the list of tags with the logged value for the BSNR, the GROUP, and @ARRIVAL/DEPARTURE. Add comment lines and mark wrong lines as "deleted" as required.



Here you will be able to share the scanned list using standard "mobile SHARE technology" Please share as often as possible, as it is using browser "local storage" technology, It is limited and intended for short-term storage only.

Clear your tags list once successfully shared and safe to do so, before scanning a new batch.

This shared data will be available for import into FLEXIAUCTION. (explained below in the FlexiAuction IMPORT FMTAG section)


FMTAG is provided free-of-charge, independent, standalone, own-risk, when-available & as-is.

FLEXIAUCTION OPERATIONS



Create and active a livestock EVENT, capture your registrations and vendueroll as per normal.


Right-click on the vendueroll



FLEXIAUCTION SHOW/HIDE TAGS

Flexiauction does allow for tags to be captured with each LOT. On the roll right-click and select "SHOW/HIDE TAGS" or press Ctrl+T to capture and manage the tags for each Lot separately. These tags will also print on all invoices and loading documentation if your templates are set to show it.

MANAGE AND IMPORT TAGS



(1)	Display the unique list of BSNR s for all the TAGS imported/added for this EVENT

(2)	Display the list of TAG s for the BSNR selected in (1)

(4)	Display all the LOT s where the BSNR selected in (1) is participating in


FLEXIAUCTION will try to determine if a BSNR with its tags are for **ARRIVAL** or **DEPARTURE** from the context:

If used in the vendueroll, it will be ARRIVAL if used SELLER side, or DEPARTURE is BUYER side.

Please use the BSNR <u>either</u> on <u>buyer</u> side <u>or</u> on <u>seller</u> side, <u>NOT</u> on <u>both</u>

- If prefixed with "NS" it will be assumed as an "NOT SOLD", and thus a DEPARTURE back to seller (treated here as "buyer")
- If it is a RMIS GLN number, it will be assumed an **ARRIVAL** from a **seller**. (not to be used directly)
- If it cannot be determined, it will be displayed in **blue** with a warning. Note that reports will be incorrect. The system will indicate with colours (**red**, **green** and **blue**) and display warnings accordingly.

E.g. "D" is linked to customer #CD/DELTA



The system will use "D" exclusively as SELLER and thus for ARRIVALS because "D" was used seller-side

Should DELTA also purchase animals, a new BSNR should be linked and used buyer-side, "D1"

Should DELTA have unsold animals, a new BSNR should be linked and used buyer-side, "NSD" Note: It is not required to change the unsold lots on the vendueroll, as it might impact your reporting. The system will "know" it is an unsold animal because of the "NS" prefix, you can just change the BSNR for the relevant tags.

Operational restrictions

Due to many factors, including:

- · time-constraints for the scanning and/or importing processes,
- · availability of tag data at invoicing/loading stages,
- internet/network/WIFI availability,
- staff availability/skill,
- device availability

we allowed for three distinct options for linking LOTS to TAGS:


OPTION	ACTIONS	BENEFIT/ DISADVANTAGE
NOT LINKED	No action	 Faster operation and easier workflow. Cannot print tags on invoice or 6/8 load docs as there is NO tags linked to the lots at all. Only TagBSNR report can be used. NOTE: THERE WILL BE NO CORRELATION AT ALL BETWEEN LOTS LISTED IN THE INVOICE AND 6/8 LOADING DOCS AND THE TAGS LISTED ON THE TAG-BSNR REPORT.
vLOT EACH TAG	Select the tag, for each tag determine the correct lot and press CTRL+2 to link that LOT to the vLOT field of the tag as well as the counter-party tag.	 Slower operation, as more FIELD INFO and more TIME is required to link the lots to the tags. Difficult to determine correct lot without additional information Cannot print tags on invoices or 6/8 loading docs. Can print delayed/separate "special" 6/8 load docs with tag info
TAG EACH LOT	Select the tag, for each tag determine the correct lot and press CTRL+1 to add tag to the "TAG field" of the LOT. (can also edit tag field manually)	 Slower operation, as more FIELD INFO and more TIME is required to link the lots to the tags. Can print tags on invoices and 6/8 load docs Will required credit notes/reversal should TAG info change on an invoice Timing issues, tags might not be available at time of invoicing. Stricter handling of invoices in regards to splitting lots. Ideally "ONE INVOICE, ONE BSNR"

Right-click options

Import from EXCEL




Open the Excel/CSV in EXCEL and press CTRL+A and Copy CTRL+C to copy it Click "PASTE SHEET "to paste the sheet Link the correct fields, by right-clicking on each column Ensure that the required fields BSNR and EID/TAG is linked correctly Select correct species and Tag Type then click "ADD TAGS" to import

Notes:

The additional helper fields Location (arrival/departure), Reference Nr, Group Nr, Kraal Nr, Mass, buyer mark, seller mark, Sex and captured Lot Nr) will be of assistance should you want to link the tags to lots.

Import from FMTAG



Paste the tag information from the location it was shared from Select correct species and Tag Type then click "ADD TAGS" to import


This function can also be used to import a standard list of tags for a specified BSNR.

TagBSNR REPORTS

A TAG-BSNR report will be generated for each BSNR from the "Manage & Import Tag" section as well as the "Invoicing | Print" screen


Prerequisites

Please obtain access token from RMIS for <u>each</u> auction venue Contact us to link your access token with your auction venue. Please treat your access tokens as private and in the strictest of confidence.


Request all customers to register for and obtain GLN numbers from RMIS Please direct them to https://productionunit.rmis.co.za/

Prior to uploading transfers to RMIS

Please ensure that the GLN is set for your EVENT Please ensure that your MAP GPS coordinates is set correctly for the auction



Click "Fetch" to use the RMIS GLN LOOKUP function to find participants.



Please ensure that all participating customers GLN fields is also linked correctly. You can use the same lookup function as above.

Ensure that ALL invoices and loading documentation is finalized and completed. Ensure that ALL tags are correctly linked to the correct customers Ensure that your auction is FINALIZED

Irrespective of when you do the uploads to RMIS, all upload to RMIS will be effective at the auction date, 12h00 noon and all queries will be from the day prior at 04h00 AM to the next day at 20h00 PM






Click Login to refresh your access to the RMIS system
Click Query/Refresh to display the list of transfers already sent/received for this auction
You will be able to click "XFER to Buyer" or "XFER from seller" depending on the BSNR selected


When BSNR selected is a BUYER, you will be presented with a list of transfers (initially blank), Click "XFER to Buyer" to SEND all animals with tags to the selected BUYER
If no destination GLN is available no action is required, traceability will end at the auction.




When BSNR selected is a SELLER, you will be presented with a list of transfers (initially blank), Click "XFER from Seller" to RECEIVE all animals with tags from the selected SELLER If the seller is not a RMIS-participant, you must still click "XFER from Seller", traceability will start at the auction.



Please note that if the seller is a RMIS-participant and already sent animals to your GLN, A new BSNR with the tag list will be created as "GLN</br>

the distribution of the seller is a RMIS-participant and either RECEIVE, REJECT or UPDATE the transfer.



Select and then right-click on the tags list and select



to link the tags to another BSNR for usage.

Right-click on animal or tag for a tag query or trace report on that tag.
